9. Re-Plat Review, Nickell School Oaks, Lots 8R-1 & 8R-2. Block 2. Precinct 2. Take necessary action. (KB)
10. Final Plat Review, Winter Oaks, Lots 1 & 2. Precinct 3. Take necessary action. (HL)
11. Final Plat Review, Deats Farm, Phase 1. Precinct 3. Take necessary action. (HL)
12. Tax Bid Sale. Lot 82, Block 1, Runaway Bay, Unit 6, Wise County, Texas. Take necessary action. (JDC)
