Anyone speaking during the Community Forum should first identify themselves by their first and last names for the public record. There is a 3-minute time limit, and large groups interested in the same topic should select a spokesperson. State law prohibits the Court from deliberating on any item not listed on the posted agenda.*) (JDC)

6. Discussion for the purpose of coordination and cooperation for efficiency between precincts. No action will be taken.
7. Discuss plat submittals. Take necessary action. (JDC)
8. Consider adoption of Resolution Regarding 2020 Help America Vote Act (HAVA), CARES Act Sub-Grant to Texas Counties for the 2020 Federal Election Cycle. Take necessary action. (JDC), (TA), (SS)
9. Discuss COVID-19-related federal/state funding. Take necessary action. (JDC)
10. Consider accepting donations of personal property and/or various revenues to County (if any). Take necessary action. (KH)

11.
