There is a 3-minute time limit, and large groups interested in the same topic should select a spokesperson. State law prohibits the Court from deliberating on any item not listed on the posted agenda.*) (JDC)

6. Discussion for the purpose of coordination and cooperation for efficiency between precincts. No action will be taken.
7. Discuss plat submittals. Take necessary action. (JDC)
8. Discuss latest COVID-19 updates, including declarations and orders. Take necessary action. (JDC)
9. Consider dates/ times/ locations for the early voting period for the July 14, 2020 Joint Primary Runoff Election. Take necessary action. (SS)
10. Consider the recommended consolidated polling locations to be used on Election Day for the July 14, 2020 Joint Primary Runoff Election. Take necessary action. (SS)
11. Consider accepting donations of personal property and/or various revenues to County (if any). Take necessary action. (KH)

12. Discuss and consider construction, initiation and/or approval of: (i) specifications pursuant to advertising for bids on one or several different items and/or services for purchase (or sale of items); (ii) purchase of specific items; (iii) consider awarding bids and (iv) consider giving of notice of cancellation(s) as/if necessary.
