8. Final Plat Review, McMullen Addition, Lots 1,2&3. Precinct 2. Take necessary action. (KB)
9. Final Plat with Construction Plans Review, Walnut Grove Estates, Phase 2-B. Precinct 2. Take necessary action. (KB)
