County Judge Clark votes aye on all agenda items unless otherwise indicated.

- 1) Clark called the meeting to order at 9:46 AM. All court members were present except Burns and Lamance.
- 2) Clark asked the court if it wishes to adopt the proposed changes to the Wise County Rules and Regulations or wait until the meeting on June 24, 2019 to allow developers time to review the proposed changes.

White told the court that dumpsters located on county roads is a safety issue and asked what can be done by the county to remedy this problem?

Welden commented that the dumpsters are in the right-of-way of the county road. The court discussed this issue further. Clark asked Commissioners Court Attorney Thomas Aaberg to review any avenues the commissioners can take regarding this issue.

Clark clarified to the developers present to give Davis or Welden their contact information so a draft of the DRR can be provided. Clark stated there are copies at the table available today. Welden confirmed that the copies at the table are NOT drafts and will provide draft copies.

White confirmed the court will meet next week and discuss the DRR for consideration of adoption of changes.

3) Clark announced the next meeting as Monday, June 24, 2019 and adjourned this meeting at 9:55 AM there being no further business to be had by the court.



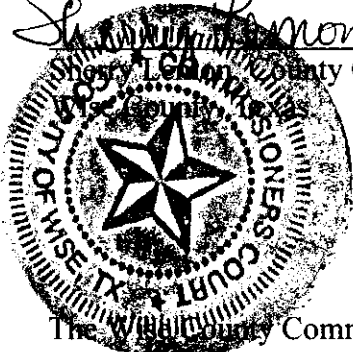
