- _____ I have proof of personal financial responsibility (automobile liability insurance- *please provide a copy*).
- _____ I am not currently nor have I taken a Driver's Safety Course for a traffic violation in the past twelve (12) months.
- _____ I was not going greater than 24 mph over the speed limit.
- _____ I was not charged with a speed of 95 miles per hour or more.

_____ **I understand that I must:**

- Pay \$146.00 to the Court on the date of my request. This must be in person or postmarked by the due date on citation. **NO PERSONAL CHECKS ACCEPTED**
- Present the Certificate of Completion of an approved Driving Safety Course; and
- Present a certified copy (Section 3A) of my driving record from the Texas Department of Public Safety by the given due date. You may obtain your driving record at <https://texas.gov>.

I further understand this offense will be dismissed after the ninety (90) day period upon providing proof of successful completion of a Driving Safety Course and a certified copy of my Driving Record.

Failure to take the course or to give the court my certificate of completion along with my Texas Driving record by the required due date, will require my appearance to show cause why proof was not timely submitted. At that time, the court may enter a judgment of guilt. If I fail to appear at the hearing, the court will enter a judgment of guilt and the offense will appear as a conviction on my driving record and a warrant may be issued for my arrest and an additional fine will be assessed.

I now enter my plea of **NOLO CONTENDERE** (No Contest) to the offense of, _____, waive a trial by jury, and ask for the court to grant me Driver's Safety.

I DECLARE UNDER PENALTY OF PERJURY THAT THE FOREGOING FACTS ARE TRUE AND CORRECT.
